Approval of the Minutes

New Business

Posting of Proposed Budget for 2022 to PARIS and at the Clinton County Government Center

M. Zurlo reviewed the proposed 2022 Budget for reporting to the comptroller's office. The 2020 numbers reflect actual revenue and expenses incurred. This year's revenue was calculated based on current projects collected thus far and those anticipated to close in 2021. 2022 revenue is based on projects currently in the pipeline and are expected to close in 2022. These include the Champlain Hudson Power Express (CHPE) and PRIME Projects, as well as a Schluter Project which will be discussed in more detail later in the meeting. T. Trahan asked why all of administrative fees and salaries are charged to the IDA rather than some being distributed to the Clinton County Capital Resource Corporation (CCCRC). G. Cregg, Jr., Esq. advised that in the past, the CCIDA may have received monetary transfers from the CCCRC in years when the CCIDA had few revenues and the CCCRC had a lot of revenue. He indicated that if the CCIDA chose to transfer some of the administrative services contract fees to the other two entities, they could.
