#### **Governance Committee**

M. Zurlo noted the Governance Committee met and reviewed the following documents for the CCCRC:

#### **FTZ Reports**

M. Ryan advised that NFI (World Warehouse) and W. Schonbek have both submitted their annual FTZ Reports and we are now able to submit our report.

# Town of Plattsburgh - Smart Growth Plan for Former Clinton County Airport

M. Ryan advised that in April, 2021, the CCCRC approved the Town of Plattsburgh's request for \$7,500 in grant funding for the Town's development of a Smart Growth Plan for the former Clinton County Airport property. The entire scope of the project totaled \$25,000. The Clinton County Board of Realtors contributed \$2,500, the National Association of Realtors awarded a \$5,000 grant, and the Town Planning and Community Development Department approved \$10,000 for the project. The \$7,500 grant from the CCCRC brought the total funds to \$25,000. The CCCRC has received an invoice from the Town of Plattsburgh in the amount of \$7,500.

On a motion by J. VanNatten, and seconded by K. Defayette, it was unanimously carried to approve payment of the \$7,500 invoice.

# **New Business**

M. Ryan advised that she met with a M. Carpenter of The Northeast Group to discuss if there was any potential for them to seek a Foreign Trade Zone designation. M. Ryan advised that while it makes sense for some businesses, it may not be beneficial to The Northeast Group.

M. Zurlo advised that our FTZ attorney, David Ostheimer, has indicated that the CCCRC has the lowest FTZ rates in the entire country. M. Ryan advised that she will be working with D. Ostheimer to discuss updating our rates, potentially establishing the rate based on how much actual foreign trade a business does.

There being no further business to discuss, on a motion by M. Zurlo, and seconded by J. VanNatten, the meeting adjourned at 1:21 p.m.
