New Business:

1. Discussion Regarding Proposed New Project – FW Webb

N. Zeigler reviewed the project summary:

- Benefits Sought: Real Estate Exemption/PILOT and Mortgage Recording Tax Exemption
- Project Description: FW Webb Company has purchased 10 acres located at 452 Tom Miller Road in Plattsburgh, tax map #206.-1-13.1. They

constructed an approximate 33,600 square foot warehouse facility and are relocating from their current location at 7327 Route 9.

FW Webb is a wholesale distributor of plumbing, heating, LP & natural gas, industrial, and HVACR products.

- Total Project Cost: \$5,357.600 Balance of the project by grants and internal funds.
- Total Jobs to be Created: 5 over 5 years

It was noted that at this time the project has already been completed and the company is making preparations for their grand opening.

The members reviewed the project application and spoke with C. Berry about the project.

After discussing the project the consensus of the members is that since the project has already been completed it would not be appropriate to grant benefits at this time.

FW Webb was notified that they have the opportunity if they so choose to present additional information to the Agency to justify seeking IDA benefits after the project was already completed. The Agency would also consider a new request from FW Webb when and if the company decides to expand the new facility.

The decision was made to table this discussion at this time.

Executive Director's Report

- P. Grasso noted that he is in continued discussions with Roseanne Murphy regarding the position of Executive Director of the CCIDA.
- P. Grasso mentioned that it was suggested that the Agency create a flyer and offer some informational sessions to educate commercial lenders and other appropriate companies on what type of IDA benefits are available, which type of companies are eligible and the process to apply.
