1. Review RFP Responses and Recommend Approval of Auditor

- Martindale Keysor: Response Received
- Abbott Frenyea: Declined, the firm believes they may be conflicted, due to Pat Russell's position as chair of TDC
- McCormick & Deon: Declined, the firm does not conduct NYS or federal agency audits.

- Alexander Edwards: No Response
- Boulrice & Wood: No Response

Martindale Keysor was the only submittal.

K. Defayette reviewed the proposal and noted that Martindale Keysor is a firm that is qualified to provide the required services.

Starting in 2016 and escalating, the CCIDA audit will be \$5,000. In 2015 the audit for the CCIDA was \$6,750.

On motion by J. VanNatten, seconded by D. Hoover, it was unanimously RESOLVED to recommend approval of Martindale Keysor for professional auditing services for the CCIDA and to move to the Full Board for acceptance and approval.
